# i. Consideration of Resolution 2022-37 Adoption of the District's Fiscal Year 2021-2022 Budget and Appropriating Funds

Ms. Burns stated that the budget had not changed since the Board last saw it at their prior meeting. It included administrative expenses for the upcoming year and that they do not anticipate field expenses at this time. Ms. Burns stated that the total amount was \$133,610. She stated that this would be funded as expenses are incurred.
